## **SPECIALTY**

### **Agriculture**

- Excess of loss and stop loss
- Focus on crop exposure
- Worldwide
- Maximum line size: \$20,000,000

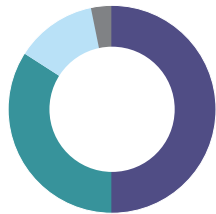
### **Political Risk / Trade Credit**

- Treaty reinsurance only on both a proportional and excess of loss basis
- Risk attaching only
- Maximum line size: \$10,000,000
- Country and coverage limitations to apply



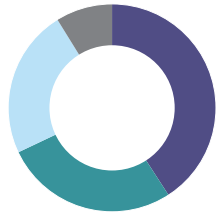
**BUSINESS BY LINE FOR 2011**

■ Specialty	12%



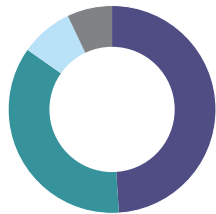
**PROPERTY BY CLASS FOR 2011**
